Weather Excessive cold/heat, strong wind, rain or a combination of above	<ul> <li>Hyperthermia / exposure</li> <li>sunstroke</li> <li>Severity moderate but likelihood minimal at this time of year and with controls in place.</li> </ul>	<ul> <li>Weather forecast monitored regularly (BS)</li> <li>Event area relatively small and not exposed.</li> <li>Relatively short courses.</li> <li>Water available at finish for any competitor in distress, should the weather be very hot.</li> </ul>
Equipment Electrical equipment	<ul> <li>Injuries as a result of trips &amp; falls</li> </ul>	<ul> <li>Cables stored mainly under tables and will not be where competitors or any other person will be walking. (BS/KH)</li> </ul>
